The scope of the Work consists of

- Development & landscaping of Kumbichchankulam Tank area and Pola road Road development, road side paving and seating with tree planting along the Pola road and Landscaping Work including hollow block paved walkways, parking areas, mini public gathering area, drinking water points, seating, tree planting and outdoor lighting system proposed done under Kubichchankulam tank area development.
- Construction of Ruwanwelisaya Vehicle Park Landscaping Work including gravel roads and hollow block paved parking areas, construction of Ticket counter, Police post, Flower shop, 02Nr sweet shops and Development of pedestrian entry to Ruwanwelisaya. with Electrical Works, Plumbing Works and necessary services.

Bidding will be conducted through the National Competitive Bidding (NCB) procedures as specified in the Procurement Guidelines for Agency for French Development (AFD) financed Contracts in Foreign Countries (February 2017 edition) and is opened for all eligible bidders as defined in the Procurement Guidelines.
