To register as a supplier, a non-refundable Rs. 1500 / - + VAT = Rs. 1620.00 registration fee is payable for each item. Bids should be sent before 19.01.2022 via registered post or hand delivered to **Construction industry development Authority, Sawsiripaya, 123, Wijerama Mawatha, Colombo 07** along with the receipt obtained after paying the registration fee to the Finance Division of the Head Office of the Construction Industry Development Authority or to **Acc. No 77454975, Torrington Branch, Bank of Ceylon**. Below is the application form which includes the details required for registration. The words "Supplier Registration - 2022" should be indicated on the upper left corner of the envelope, in which the documents are sent.

If the supplier is registered for VAT payment, a copy of the certificate obtained from the Inland Revenue Department stating the VAT tax number should be attached to the application.
